SHELBY COUNTY LAWYER CENSURED

On January 28, 2015, the Supreme Court of Tennessee publicly censured Bradley Aaron Teplitsky, of Toronto, Ontario, Canada, who formerly practiced law in Shelby County, Tennessee.

The Board of Professional Responsibility filed a Petition for Discipline against Mr. Teplitsky based on a complaint of misconduct. A Hearing Panel for the Board of Professional Responsibility found Mr. Teplitsky submitted a false affidavit to the Tennessee Commission on Continuing Legal Education and Specialization claiming to have attended two (2) Memphis Bar Association seminars and concluded that Mr. Teplitsky should receive a public censure for his conduct. Mr. Teplitsky appealed the Hearing Panel's decision to the Shelby County Chancery Court which affirmed the decision of the Hearing Panel. Thereafter, Mr. Teplitsky filed a notice of appeal to the Tennessee Supreme Court. The Court dismissed Mr. Teplitsky's appeal for failure to file a transcript of the evidence. The Supreme Court approved the Hearing Panel's Order as the Court's final order in the matter. The Court further ordered Mr. Teplitsky to pay the costs and expenses of the disciplinary proceeding.

By his conduct, Mr. Teplitsky violated Tennessee Supreme Court Rules of Professional Conduct 8.4(c) (misconduct) and is hereby Publicly Censured for the violation.

A Public Censure is a rebuke and warning to the attorney, but it does not affect the attorney's ability to practice law.

ORDER OF ENFORCEMENT

This matter is before the Court upon a Petition for Discipline against Bradley Aaron Teplitsky filed June 22, 2011, in Docket No. 2011-2056-9-KB, by the Board of Professional Responsibility ("Board"); upon an Answer filed by Mr. Teplitsky on August 31, 2011; upon the Findings and Recommendations of the Hearing Panel on May 30, 2012; upon consideration and approval of the Findings and Recommendations of the Hearing Panel on June 22, 2012; upon the Order of Final Judgment entered by the Chancery Court of Shelby County, Tennessee, affirming the Findings and Recommendations of the Hearing Panel, entered October 29, 2013; upon the Order of the Supreme Court dismissing the appeal entered December 3, 2014; and upon the entire record in this cause.

From all of which the Court approves the Order of the Hearing Panel and adopts the Hearing Panel's as the Court's Order.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COURT THAT:

- (1) Pursuant to Tenn. Sup. Ct. R. 9, §§ 4.4 and 4.7 (2006), Bradley Teplitsky is hereby publicly censured.
- (2) Pursuant to Tenn. Sup. Ct. R. 9, § 18.5, this Order shall be effective ten (10) days after the date of entry.
- (3) Pursuant to Tenn. Sup. Ct. R. 9, § 24.3, Mr. Teplitsky shall pay to the Board of Professional Responsibility the expenses and costs of this matter in the amount

of \$8,529.09 and shall pay to the Clerk of this Court the costs incurred herein, within ninety (90) days of the entry of this Order, for all of which execution may issue if necessary.

(4) The Board of Professional Responsibility shall cause notice of this discipline to be published as required by Tenn. Sup. Ct. R. 9, § 18.10.
